INVESTMENT POLICY OF THE FUND

The Fund's aim is to function as a stable, low-risk form of investment, while providing investors with higher returns than they could expect from bank deposits. In order to ensure liquidity, the Fund intends primarily to hold in its portfolio government bonds and discount treasury bills issued by the Government Debt Management Agency (ÁKK) and bonds issued by the National Bank of Hungary (MNB). The weighted average maturity (WAM) of the assets in the portfolio may not exceed 6 months and the weighted average life (WAL) of the assets may not exceed 12 months. The Fund may hold in its portfolio low-risk debt securities issued by banks and companies, which are expected to provide higher returns than government securities and are denominated primarily in HUF, but also in other currencies. The Fund may also invest to a limited extent in government securities or guaranteed bonds issued by the OECD or a G20 country, or any debt security issued or guaranteed by the central government or a regional or local government or the central bank of any EU Member State, or by the European Union, the European Central Bank or the European Investment Bank. The weighted average maturity (WAM) of the assets in the portfolio may not exceed 6 months and the weighted average life (WAL) of the assets may not exceed 12 months. In addition, the remaining time to maturity of each security is a maximum of 2 years and a maximum of 397 days until the nearest interest-rate determination date. The Fund may also keep its liquid assets in bank deposits. The fund may hold a limited amount of foreign currency assets in its portfolio, but only subject to the full hedging of currency risk.

MARKET SUMMARY

In March, Hungarian inflation have slowed more than market expectations, with the rate of price increases decreased from a peak of 5.6% to 4,7%. In mid-March, due to high food inflation, the government introduced a margin cap on 30 essential food items, meaning that retailers' profit margins were capped at 10% for these products. The regulation came into effect in the middle of the month, so it did have a minor impact on March inflation. However, according to the central bank's calculations, the measure could reduce April and May inflation by 0.8 percentage points. The cap is planned to remain in place until the end of May, but based on previous policy series, its extension cannot be ruled out. At its March rate-setting meeting, the Monetary Council did not change the key interest rate, which remains at 6.5%. According to the newly released inflation report, inflation risks for this year have increased, and the central bank has revised its forecast for average inflation this year upwards. The average inflation for 2025 is now expected to fall within the range of 4.5% to 5.1%. At the same time, the GDP growth forecast was lowered, suggesting that the Hungarian economy could grow between 1.9% and 2.9% in 2025. During the month, short-term yields rose, bringing them closer to the base rate which we have not seen in a long time. The 3-month reference yield increased by 21 basis points to 6.2%, while the 6- and 12-month reference yields closed the month at 6.21% and 6.24%, respectively. Thanks to the more favorable yield levels, we became more open to purchasing longer-term securities, and thus, during the month, we slightly increased the duration of the fund.






NET PERFORMANCE OF THE SERIES
