## INVESTMENT POLICY OF THE FUND

The Fund's aim is to function as a stable, low-risk form of investment, while providing investors with higher returns than they could expect from bank deposits. In order to ensure liquidity, the Fund intends primarily to hold in its portfolio government bonds and discount treasury bills issued by the Government Debt Management Agency (ÁKK) and bonds issued by the National Bank of Hungary (MNB). The weighted average maturity (WAM) of the assets in the portfolio may not exceed 6 months and the weighted average life (WAL) of the assets may not exceed 12 months. The Fund may hold in its portfolio low-risk debt securities issued by banks and companies, which are expected to provide higher returns than government securities and are denominated primarily in HUF, but also in other currencies. The Fund may also invest to a limited extent in government securities or guaranteed bonds issued by the OECD or a G20 country, or any debt security issued or guaranteed by the central government or a regional or local government or the central bank of any EU Member State, or by the European Union, the European Central Bank or the European Investment Bank. The weighted average maturity (WAM) of the assets in the portfolio may not exceed 6 months and the weighted average life (WAL) of the assets may not exceed 12 months. In addition, the remaining time to maturity of each security is a maximum of 2 years and a maximum of 397 days until the nearest interest-rate determination date. The Fund may also keep its liquid assets in bank deposits. The fund may hold a limited amount of foreign currency assets in its portfolio, but only subject to the full hedging of currency risk.

VIG Moneymarket Fund is not a guaranteed investment. The risk of loss of the principal is to be borne by the investor. VIG Moneymarket Fund does not rely on external support for guaranteeing the liquidity of the fund or stabilising the NAV per unit or share.

## MARKET SUMMARY

In June, Hungarian inflation may have risen slightly again according to market expectations, with the annual rate of price increases potentially accelerating from 4.4% to 4.5%. In its latest inflation report, the MNB revised both the average inflation for this year and the GDP forecast for 2025 downward. Regarding inflation, only a slight adjustment was made: the 2025 expectation was lowered from 4.8% to 4.7%. However, the GDP projection was significantly downgraded from 2.4% to 0.8%. The downward revision of the GDP forecast is primarily due to the weak GDP data from the first quarter and the uncertain external environment caused by the tariff war. Despite all this, the Monetary Council did not change the key interest rate at its June rate-setting meeting, so the base rate remains at 6.5%. Communication remained hawkish, with the Monetary Council stating that the time has not yet come for further interest rate cuts. During the month, short-term yields decreased: the 3-month reference yield fell from 6.15% to 5.95%, the 6-month from 6.22% to 6.03%, and the 12-month from 6.25% to 5.97%. The decline in yields was largely influenced by the increased demand resulting from the large volume of government securities maturing at the end of June. As a result of the decrease in short-term yields, we slightly reduced interest rate risk, as we believe a short-term normalization is expected.






