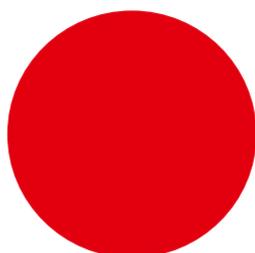


Bonds by tenor:
