INVESTMENT POLICY OF THE FUND

The objective of the Fund is to create a highly defensive investment portfolio for its Investors, which typically invests in developed-market government bonds and related exchange-traded derivatives. According to the intentions of the Fund Manager, the bulk of the Fund's portfolio is made up of bonds issued by foreign states and foreign companies through public offerings. With regard to foreign securities, the Fund only purchases publicly traded securities listed on a foreign stock exchange. It keeps the planned share of non-investment grade securities low. The proportion of bonds that can be held in the Fund at any given time may reach the prevailing legal maximum. In order to ensure liquidity, the Fund may purchase Hungarian government securities (primarily discount treasury bills) and MNB bonds. The Fund Manager has the option, at its own discretion, of hedging all or part of its foreign exchange risks using forward currency positions subject to observing the applicable legal requirements.

MARKET SUMMARY

The dominant theme across global fixed income in July was the inflationary overhang from the US-Iran conflict. Surging oil prices (Brent briefly crossed \$100/bbl late in the month) kept rate expectations elevated across major central banks, with expectations that the conflict could keep global borrowing costs higher for years to come. The ECB held its deposit rate steady at 2.25% throughout July at recent meeting, a decision that was unanimous – though notably, some policymakers had discussed an immediate hike before settling on a hold. President Lagarde reiterated a data-dependent, meeting-by-meeting approach and cautioned that the full impact of the energy shock had yet to play out. German Bund yields moved higher over the month, driven by oil-price-induced inflation fears and the ECB's hawkish hold. The clearest divergence last month was France underperforming vs. periphery – a reversal of the traditional core/periphery dynamic. Political risk in Paris is now commanding a premium comparable to Italy, while Spain and Portugal trade as the relative safe havens within the EZ sovereign space. July was a month of hawkish holds and oil-driven yield pressure in Europe. The ECB kept rates at 2.25% but left the door firmly open for a September hike, keeping Bund yields elevated and the EUR rates curve in focus heading into Q3.

In July, the Fund closed the month with a 0.21% gain in forint terms. This appreciation was driven by foreign currency-denominated assets strengthening as a result of the forint's depreciation, even as global bond yields rose due to the unresolved conflict involving Iran and persistently high oil prices. Regarding the Fund's composition, we sold existing Serbian euro-denominated government bonds and exchanged them for a newly issued series offering a higher yield spread. Furthermore, capitalizing on the rise in global yields, we increased the Fund's interest rate risk exposure regarding USD and GBP assets.

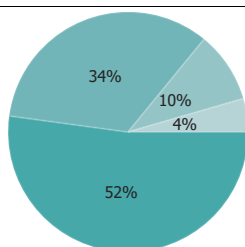

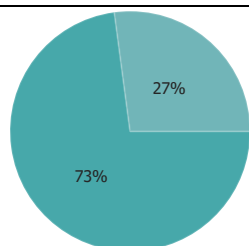

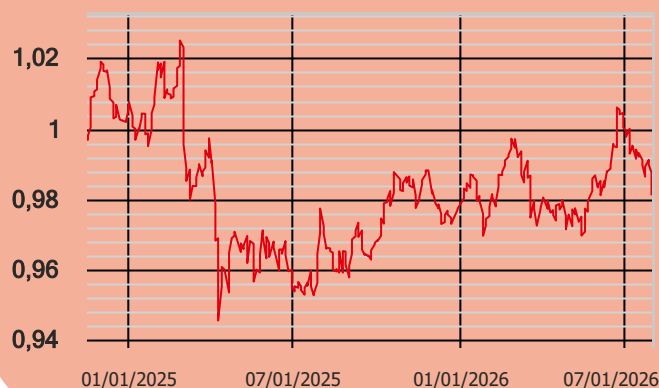
