INVESTMENT POLICY OF THE FUND

The objective of the fund is to offer to the investors calculable investment yields at low risk. The Fund Manager may exclusively invest its fund assets in bond-type assets, mainly securities issued or guaranteed by the Polish State. Furthermore, the Fund may to a limited extent invest in debt and equity securities issued or guaranteed by the European Union, or its organization, the European Central Bank or the European Investment Bank, provided that its credit rating is at least equal to that of the Polish state and is denominated in Polish zloty. Weighted average remaining duration of the assets in the portfolio of the Fund may not exceed 6 months, and the weighted average remaining life of the assets may not exceed 12 months. In addition, the remaining term of the individual securities can be no more than years, or 397 days until the next interest determination date. For the sake of liquidity, the Fund may keep its financial assets in form of bank deposit, as well. Assets of the Fund are 100% denominated in Polish zloty.

VIG Polish Moneymarket Fund is not a guaranteed investment. The risk of loss of the principal is to be borne by the investor. An investment in VIG Polish Moneymarket Fund is different from an investment in deposits, with particular reference to the risk that the principal invested in VIG Polish Moneymarket Fund is capable of fluctuation. VIG Polish Moneymarket Fund does not rely on external support for guaranteeing the liquidity of the fund or stabilising the NAV per unit or share.

MARKET SUMMARY

The ceasefire signed between Iran and the United States in June proved to be short-lived, as tensions in the Middle East escalated once again in mid-July. Following the relative calm seen after the June agreement, missile, drone, and maritime attacks resumed on a regular basis. The Strait of Hormuz remained the focal point of the conflict. Global oil prices rose significantly again during the month, although they remained well below the previous peak. Diplomatic efforts took a back seat, although mediation attempts periodically emerged, eventually contributing to some normalization in oil prices. As a result, Polish government bond yields rose significantly across the curve during the month, with the three-year maturity increasing by 40 basis points, the five-year by 53 basis points, and the ten-year by 50 basis points. At its early July monetary policy meeting, the National Bank of Poland left the policy rate unchanged at 3.75%. The central bank's communication remained broadly neutral. However, Governor Glapiński did not rule out the possibility of a rate cut after the summer months, while other members of the Monetary Policy Council continued to advocate a more cautious approach. According to the preliminary estimate, annual inflation accelerated to 3.0% in July from 2.5% in the previous month. The increase was primarily driven by the restoration of the VAT rate on motor fuels from 8% to 23%. Industrial production expanded by 7.6% year-on-year in June 2026. Retail sales also strengthened, rising by 6.2% compared with the same period a year earlier.

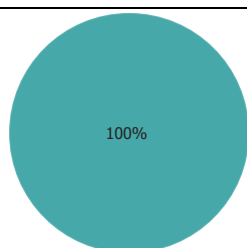

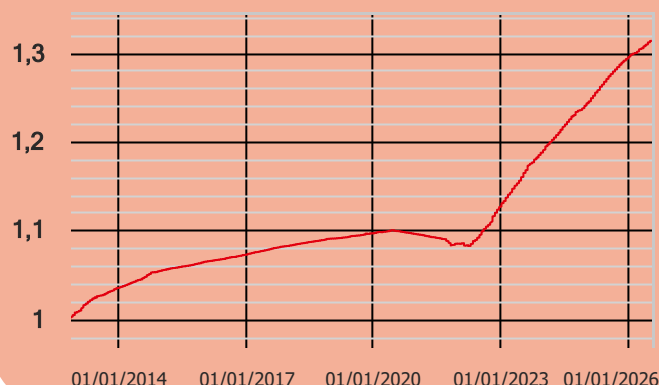
