INVESTMENT POLICY OF THE FUND:

The fund's investment objective is to provide investors with a higher return than that attainable in the domestic money market, primarily by investing in the bond market of the Central and Eastern European region. The fund's bond investments are mainly concentrated in the corporate and mortgage bond markets, but government securities issued in foreign currency are also potential investment targets. Forint-denominated Hungarian government securities are only held for liquidity management purposes. The fund may also buy into other investment funds that invest in the above markets. The achievement of a higher return than would be attainable in the Hungarian government securities market is made possible by the better diversification, the additional yield from the premiums of the bonds, and, in a favourable market environment, by the price gains resulting from the narrowing of the premiums. The fund's general risk level and the asset allocation between the three main areas of investment is determined on the basis of a regular market analysis and situational analysis relating to four main aspects (fundamentals, valuation levels, market sentiment, technical factors). The in-depth analysis is also an important factor in the selection of the individual securities by region, sector and interest risk. In the course of selecting the individual securities, a thorough financial analysis is also essential to determine the creditworthiness of the issuer. Risk management and the regular monitoring of the issuers are of key importance to the fund. When compiling the fund's portfolio we aim to achieve a moderate risk profile, primarily purchasing investment-grade securities. The fund only buys lower-rated instruments in limited proportions. The fund may only conclude derivative transactions for the purpose of hedging or ensuring an efficient portfolio structure. The fund may also hold unleveraged collective investments linked to derivative indexes. The fund also has the option of taking on a substantial currency exposure, which will ordinarily be fully hedged, although dependir on market circumstances the fund may even have an open currency position. The fur management company, exercising all due care, based on its own judgement and decision and while observing the relevant legal provisions and the limitations stipulated in the Fund Documentation, determines the means of utilising the fund's resources, and the weights of the various investments within the portfolio, with a view to ensuring that the fund - in line with our expectations with regard to future risks and returns - achieves its objective in the long term.

MARKET SUMMARY

December has brought no change in terms of the downward sliding of the oil prices. The prices of the energy source have fallen by a remarkable 25%. As the sanctioned-hit, oilexporter Russia is facing huge economic challenges (expected fall in real GDP around 4,5% in 2015), its currency deteriorated significantly in the first half of December. In order to maintain the stability of the Rubel, the Central Bank of Russia increased its key policy rate to 17% by a 650 basispoints increase, which was just enough to trigger a huge havoc after a short lived relief on the Rubel's market. The panic has quickly shifted to other capital markets as well and the supposedly calm weeks before Christmas has quickly turned into nightmare on the markets. The sentiment had its affect on emerging market hard currency bonds. The USD denominated EM sovereign bonds posted a -2,87% in December, on a sub-region level Europe was the worst performer, while Asia remained quite resilient, the performances were -4,3% and -0,34% respectively. We have added further Hungarian exposure to our positions with bonds denominated in JPY and GBP, and we also increased our duration in MOL corporate bonds denominated in EUR.
