INVESTMENT POLICY OF THE FUND:

The fund's aim is to assemble an investment portfolio for its investors that is comprised of both Hungarian and international money and capital-market instruments, which the fund can optimise through ongoing dynamic asset allocation in order to attain the highest possible yield. The fund is a 'total-return fund', which means that instead of concentrating on just one subsector of the money or capital market, at any given moment it focuses its investments on the area that holds the promise of the highest possible return. Accordingly, the fund may hold government securities and discount treasury bills issued by the State Debt Management Centre (ÁKK) on behalf of the State of Hungary, as well as bonds issued by the National Bank of Hungary, and also bank and corporate bonds that are low risk but are nevertheless likely to earn a higher return than government securities. Besides these the fund's portfolio may also contain shares listed on the domestic stock exchange and the bourses of OECD countries, as well as the government securities, bank and corporate bonds of OECD countries. The fund does not follow a fixed benchmark, and does not adhere to a permanent ratio of shares to bonds, but aims to constantly change this ratio within a broad range; indeed, it is also prepared to take on currency risk (just as international bond/equity funds tend to) through the purchase of international government securities and equities. At the same time, the fund maintains the option to hedge currency risks.

MARKET SUMMARY:

Concerns of the timing of US rate hikes, a strong dollar and slowing growth in China weighed on sentiment in March, but Janet Yellen's comments, that interest rate hikes would be gradual to avoid undermining US economic expansion, and speculation China would take more action to support the economy helped risk markets recover later in the month. We saw the ECB begin QE, which supported European yields, while the clear winner of a weak EUR has been European equity markets. Oil continued its volatile trading, while Greek assets stumbled but remains isolated just like the Ukrainian conflict.

The fund benefitted from equity positions as European and Japanese markets performed well, although the US consumer story looked to have stalled. Our local bond holdings had a volatile month, but we remain bullish particularly on the belly of the curve. USD duration hurt as well, but we are constructive on spreads as the yield hunt remains in tact. We are slightly long HUF as the break below 300 could last longer.
