

INVESTMENT POLICY OF THE FUND

The Fund's aim is to function as a stable, averagely low-risk form of investment, while providing investors with higher returns over the medium term than they could expect from bank deposits. In order to ensure liquidity, the Fund intends primarily to hold in its portfolio government bonds and discount treasury bills issued by the Government Debt Management Agency (ÁKK) on behalf of the Hungarian State, and bonds issued by the National Bank of Hungary (MNB). The Fund may hold in its portfolio low-risk debt securities issued by banks and companies, which are expected to provide higher returns than government securities and are denominated in HUF. The Fund may also keep its liquid assets in bank deposits. The fund may hold a limited amount of foreign currency assets in its portfolio, but only subject to the full hedging of currency risk.

MARKET SUMMARY

The pace of price increases in Hungary continued to slow in April. Year-on-year inflation came in at 24%, which was a positive surprise for the market. In April, the government took further measures to curb inflation. The food price freeze, previously in place until the end of April, was extended until the end of June, and it was announced that a compulsory promotion in grocery stores for certain basic food groups will be introduced from 1 July. It remains to be seen whether the intervention in food prices has lived up to expectations, but it is clear that we have the highest food price inflation compared to our neighboring countries. At the April rate-setting meeting, the Monetary Council left the base rate unchanged, but lowered the upper limit of the interest rate corridor from 25% to 20.5%. In doing so, they indicated that the rate cut could start soon and that they will decide on the evolution of the effective interest rate depending on the risk perception. News also emerged during the month concerning fund managers: from 1st of July 2023, each investment fund will have to have a minimum 60% of securities in its portfolio. This could create significant demand in the Hungarian government bond market. Bond yields declined during the month, with yields falling by 46 basis points on the 3-year maturity, 70 basis points on the 5-year maturity and 75 basis points on the 10-year maturity. We remain positive on the asset class as economic activity slows and interest rate cuts approach.

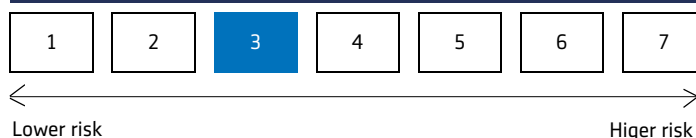

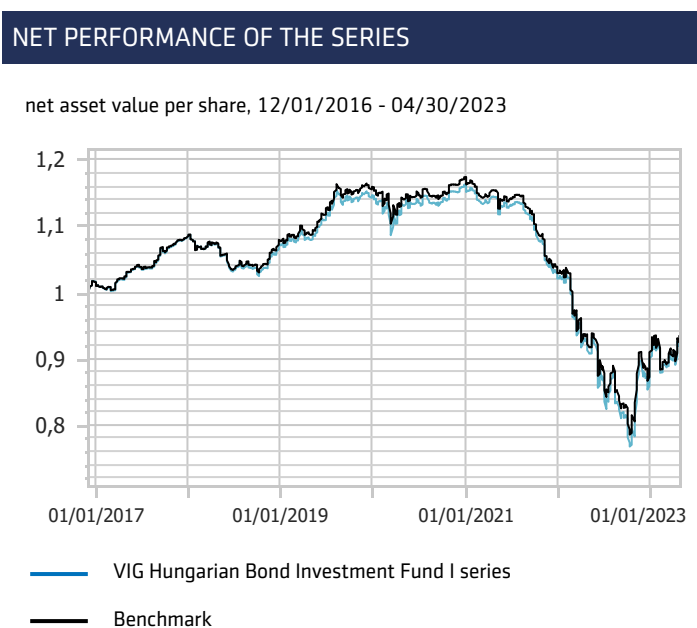
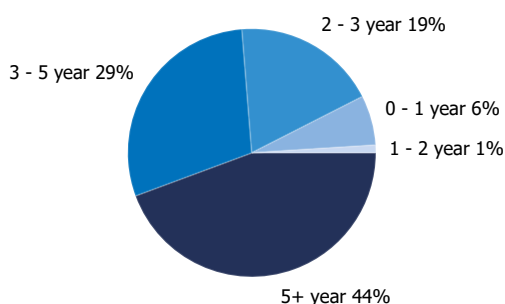
