

INVESTMENT POLICY OF THE FUND

The objective of the investment fund is to make the Polish bond market accessible to the investors, and to function as a relatively stable, medium-risk investment form bringing steady real yields to our Clients on middle term already, without having to tie down their money for a fixed period of time. The Fund mainly invests in Polish government securities issued in zloty, however, the portfolio manager has some room to complement the portfolio with other bond-type investments. Our goal is to achieve the highest yield while taking the lowest risk. To make investment decisions we use the tools of both fundamental and technical analysis, and we take into consideration the investor sentiment on the markets at all times. The portfolio manager seeks out potential investment opportunities based on the macro-economical expectations, the expected yield curve, the return expected on the curve and the market volatility, and selects investments that are considered to be safe and bring relatively high yields in exchange for the risks taken. The Fund strives for complete exchange risk coverage of foreign currency exposure for the target currency.

MARKET SUMMARY

In June Polish bond market had a moderately positive performance, yields decreased along the yield curve. Two-year yields decreased by 15 basis points, but 10-year yields also managed to end the month almost by 30 basis points lower. According to preliminary data, headline CPI in June decreased to 11,5% from May's 13% (YoY), and also came in below market expectations (consensus was 11,8%), mainly driven by fuel, food and energy. High frequency data in June confirmed that economic activity in Poland kept falling but at a slower rate than in April: slowdown is significant, but so far a deep recession is not expected by analysts. The Polish central bank kept the base rate at 6.75% but probability for rate cut(s) increased recently. However, new round of fiscal loosening, strong labour market and elevated and slowly sliding core inflation limit the room for monetary easing. Premature rate cuts in Poland might mean that it will take a very long time for inflation to return to target: models show that core inflation may stabilise around 5% YoY in 2024-25 in that case. Most probably we may see a rather symbolic rate cut by 25bps this year around November, but we see a possible risk for quicker (already in September) and deeper rate cuts. We hold a rather neutral allocation during the month, but we had a tilt towards longer dated bonds and inside neutral band we had slight overweight, which altogether added to our monthly performance. Also our carry assets performed well.

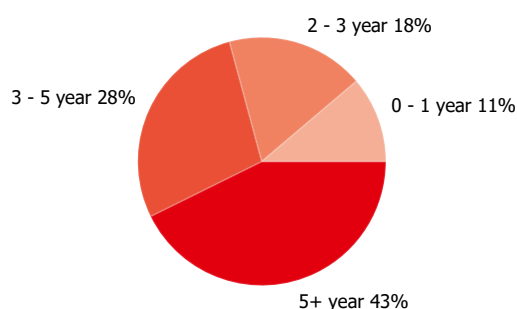

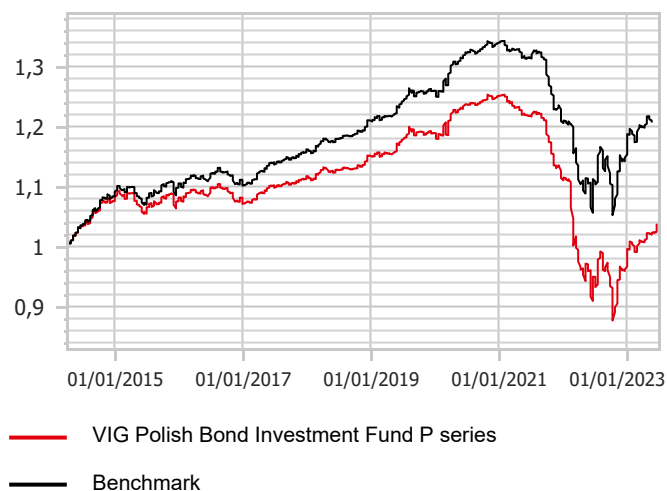
