

INVESTMENT POLICY OF THE FUND

The Fund's aim is to function as a stable, averagely low-risk form of investment, while providing investors with higher returns over the medium term than they could expect from bank deposits. In order to ensure liquidity, the Fund intends primarily to hold in its portfolio government bonds and discount treasury bills issued by the Government Debt Management Agency (ÁKK) on behalf of the Hungarian State, and bonds issued by the National Bank of Hungary (MNB). The Fund may hold in its portfolio low-risk debt securities issued by banks and companies, which are expected to provide higher returns than government securities and are denominated in HUF. The Fund may also keep its liquid assets in bank deposits. The fund may hold a limited amount of foreign currency assets in its portfolio, but only subject to the full hedging of currency risk.

MARKET SUMMARY

Economic growth was softer than expected, 2nd quarter QoQ GDP growth was -0.3%, the fourth consecutive quarter with economic contraction. This probably means full-year 2023 growth will be at most flat. Recessionary environment had a positive effect on the disinflation process. Headline CPI declined quicker than expected during the summer (to 17.6% yoy by July) and is forecast to fall close to 7% by the end of the year. The currency traded below 390 for most of the month. The central bank continued its gradual rate hike cycle as the disinflation process and better external accounts still support lower rates. Ten-year yields rallied back below 7% after a short lived spike while short yields remained under pressure by technical buying from local banks and limited supply in the very short segment, thus closed the month at ytd lows despite higher core market yields.

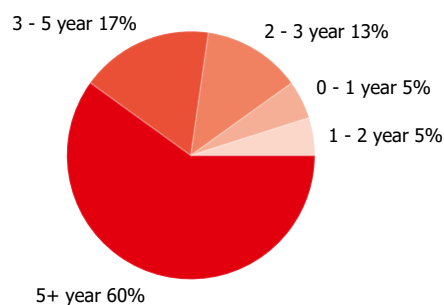

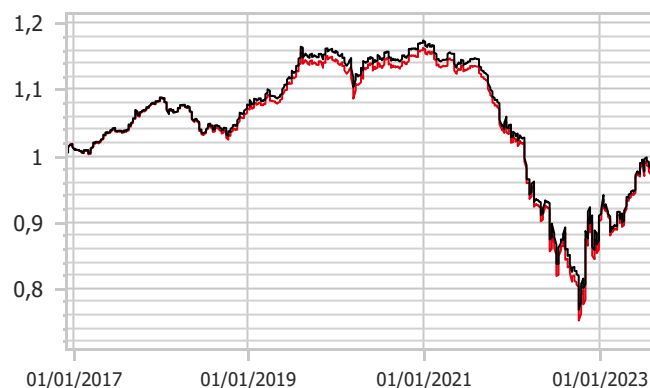
