## INVESTMENT POLICY OF THE FUND

The Fund's aim is to function as a stable, averagely low-risk form of investment, while providing investors with higher returns over the medium term than they could expect from bank deposits. In order to ensure liquidity, the Fund intends primarily to hold in its portfolio government bonds and discount treasury bills issued by the Government Debt Management Agency (ÁKK) on behalf of the Hungarian State, and bonds issued by the National Bank of Hungary (MNB). The Fund may hold in its portfolio low-risk debt securities issued by banks and companies, which are expected to provide higher returns than government securities and are denominated in HUF. The Fund may also keep its liquid assets in bank deposits. The fund may hold a limited amount of foreign currency assets in its portfolio, but only subject to the full hedging of currency risk.

#### MARKET SUMMARY

In March, the pace of price increases in Hungary slowed further, but consumer prices have risen above the market expectations by 3.6% over the year. This means that for the third consecutive month this year, domestic inflation has remained within the central bank's tolerance range. During the March rate setting meeting, the central bank returned to a 75 basis point rate cut, bringing the base rate down to 8.25%. Barnabás Virág, Deputy Governor of the central bank emphasized in his communication that a phase of monetary easing had concluded, and from April onwards, rate cuts would proceed at a slower pace. The slowdown of rate cuts is mainly due to the risk of inflation rising again. The expected level of the base rate for mid-year has also shifted somewhat higher, with the central bank currently seeing a base rate between 6.5-7% as realistic. According to the new Inflation report published by the Central Bank, average inflation for 2024 can be between 3,5% and 5%, but GDP growth is expected between 2-3%. During the month, apart from shortterm yields, we observed a weakening across the yield curve. Yields rose by 60 basis points at the 3-year maturity, by 70 basis points at the 5-year maturity, and by 43 basis points at the 10-year maturity. Consequently, the valuation of domestic bonds further improved. According to official data, the budget deficit amounted to 6.7% of GDP last year, marking the fourth consecutive year when the deficit in Hungary exceeded 6%. The deficit target for this year has also been revised, with the 2024 figure raised to 4.5% of GDP. As a result, the Government Debt Management Agency (ÁKK) has also adjusted its financing plan. The net financing requirement for 2024 will be 3,982 billion forints, which is 1,467 billion forints higher than the plan announced in December.




